Welcome

Commissioners welcomed and thanked everyone for their participation and reiterated the big picture goal of the committee and the current task of funding recommendations.

Discussion

- Grantee information updates that were received since the June 4th meeting were reviewed. Pisgah Legal Services provided partial funding information. Community Action Opportunities provided some budget information. YWCA and Asheville City Schools provided additional information. Those updates were emailed to committee members earlier today. Since that email, information was received from Buncombe Partnership for Children on behalf of Buncombe Partnership for Children, Hawthorne Montessori, Irene Wortham. Additionally, Commissioners received verbal updates from Buncombe County Schools. Their ECE centers at Enka and Owen are both over a year away, but North Buncombe has a room available which could be up fitted for \$450,000 by January 1st. The Buncombe County/Verner partnership application updated that partial funding of \$500,000-\$700,000 would allow the project to begin, with potential timeline impact.
- Discussion of grant scoring and funding recommendations. Committee members ranked their top 10 and top 3 projects. This ranking was considered in addition to the project ranking that was created through the online scoring process. Once the top projects were determined, the committee began discussing different funding scenarios. The committee decided to do away with the \$100,000 technical fund and instead those funds to projects.
- The committee was polled for support between Scenario 3 and Scenario 4 (reference page 2 of these minutes): Scenario 3 received 6 votes, and Scenario 4 received 8 votes.
- Kit Cramer made a motion, and Commissioner Whitesides seconded the motion to recommend Scenario 4 for approval by the Board of Commissioners. It was approved by unanimous vote.

Next steps

- Recommendation will go before the Commissioners on June 18th
- Committee to consider structure and chair/vice chair at next meeting
- Committee to hold an evaluation/debrief discussion on the funding process at next meeting
- Committee to develop plan for multi-year funding at a future meeting
