










About 1 in 12 criminal incidents in Buncombe County had at least one missed court appearance

State Non-Appearance Rate: 14.80%






Most common nonappearances were for administrative traffic offenses

Nonappearances by Offense, 2018-2021

Underlying Offense	Count
Expired Registration Card or Tag	1,175
Driving While License Revoked - Not Impaired	905
No Operator's License	799
Operating a Vehicle with No Insurance	540
Speeding	489

Court nonappearances **dropped** in 2020, even before the March stay at home order

Number of nonappearances by incident initiation year for Buncombe County, 2015-2021




Nonappearance Rates for Criminal Incidents Initiated 2019-2020



Sign up for court date reminders!



Step 1: Know your case number.

If you don't know your case file number, you can find it by looking up your case details online. Go to nccourts.gov/court-dates to find your case file number, county, and other details about your case.

Step 2: Enroll online.

Take a picture of the below QR code, then enter your county and case number. You can choose to receive text-message or email reminders about your upcoming court date. Standard message rates apply but the service is free. Anyone can enroll!



Don't forget! Missing has consequences.

If you don't show up to court or resolve your case, you may be **arrested**. For many traffic violations, if you fail to appear your **driver's license will be revoked**.






