#### **WORKFORCE HOUSING LOAN PROGRAM**

- Application: Requested as part of 9% LIHTC application
- Source: State funds
- Purpose: Fill funding gaps in 9% LIHTC projects
- Maximum Awards: Based on County income level (Buncombe is a high-income County so lowest awards available)
- Terms: 0% interest, 30 year balloon (no payments)

#### WHLP CV (COVID) GAP LOANS

WHLP CV (Covid) Gap Loans

- Increased funding to assist distressed affordable housing projects
- \$181,050,700 in total WHLP CV funds recently awarded
- Buncombe County Projects receiving WHLP CV Funds:
  - \$367,000 The Villas at Swannanoa (60 unit (Senior (55)))
  - \$256,600 Jasper (84 unit (Family))

# ARPA FRF ER PROGRAM SCOPE

- Award: \$400,000
- Purpose: Home repairs which exceed current ASHP program caps
- Allows for more comprehensive repairs to improve health and safety of the most vulnerable
- Expenditure Per Unit Range: >\$15,000 to \$30,000
- Estimated Impact: 12 to 24 Units Repaired
