Guest Speaker Steve White

Steve spoke as the Senior Director of Barium Springs and gave an overview of the program.

- DJJ sends referrals once they are adjudicated
- JCPC funds are used to pay for treatment for those unable to pay for the program, Medicaid
 pays per service as well, and the programs finds other resources to help with finance as JCPC
 and Medicaid won't pay for intake unless Adjudicated.
- It's a 9-12 month program with 5 stages that includes the following: licensed professional that is trauma informed and provided crisis support. Supporting the clients, the parents and all those involved.
- Creating a safety plans with clients, their home and the community.
- It takes 3-4 weeks to evaluate the circumstances and provide a recommendation to all involved judicially.
- Have 3 kinds of referral:
 - None Adjudicated (involves evaluation before proceeding)
 - Pre Adjudicated (involves evaluation and safety procedures)
 - Are Adjudicated (full involvement)

Will work with all as long as the family is willing.

NCDPS Community Programs Update

Regina Arrowood

- Updates on the JCPC funds no changes other than there is a budget revision from a contractor
 to a part-time position at the County. The county is now handling it within and requested
 approval on hiring a part time coordinator to handle the basic needs for the JCPC
- Regina introduced Lauren Williams who will serve as the full time Area Consultant in Buncombe County.
- Department of Public Safety new policy and procedures will be explained in detail via Web-ex on September 7th, 14th, and 28th.

- Legislature changes for JCPC will begin Dec. 1, 2020. These things have passed and will take effect December 1, 2020
 - Meetings 6 times per year minimum
 - o Risk & Needs Every 2 years vs every year. This year will be the same.
 - Youth advocates have passed
- July 1, 2020 Bill change. It allows JCPC's to have 2 year funding cycles. This will not take away from our accounting each year.
