TASK Program Update

Cindy Porterfield, Director, Juvenile Community Programs

Cindy Porterfield, Director of Juvenile Community Programs with NCDPS, announced that Children's Hope Alliance's programs Treatment Alternatives for Sexualized Kids (TASK) and Comprehensive Evaluations of Sexual Harm (CESHs) will become available to Buncombe County through a state contract. This will allow Buncombe County to continue to access services, while freeing up JCPC funding previously allocated to TASK and CESH.

NCDPS Court Juvenile Justice Update

Sylvia Clement, Chief Court Counselor

- Name has changed back to Juvenile Justice Delinquency and Prevention
- Seeing numbers increasing with fights, truancies, and some weapons charges. Seeing more referrals than assessment slots; Youth Villages is working to increase slots for JJ.
- Issues with detention as some kids are in detention with COVID, so that is limiting detention capacity and court counselors are traveling farther to see kids (e.g. Cabarrus) as Alexander and Madison have been at capacity.
- Hired new staff and still hiring for open positions.

Area Consultant Update

Lorraine Williams

- Year-to-Date Program Report: Programs have served 123 youth served to date (52% of projections), 86% were referred from Court Services, 1/3 of youth are 16 and older.
- Intensive Intervention Services grant applications are open and due March 7th. Serve a higher level of need (Alternatives to Commitment and Level 2 funding combined to make this pot of funding). This is what is funding TASK moving forward.
- 3rd Quarter Accounting coming up.
- Traffic Teen Court Information Session recorded and available for viewing. Restorative Justice training is available through the Restoring Youth Coalition of NC (RYCNC).
