MINUTES OF OCTOBER 28, 2014**

THE BUNCOMBE COUNTY BOARD OF ELECTIONS MET ON OCTOBER 28, 2014 AT 5:30 P.M., AT 35 WOODFIN STREET, MEETING ROOM #330, IN ASHEVILLE NORTH CAROLINA, WHERE AND WHEN THE FOLLOWING BUSINESS WAS TRANSACTED:

The meeting was called to order at 5:31 p.m. The Chair announced the Boards intent to proceed with the challenge hearing at 5:35 p.m. The hearing ended at 5:50 p.m. (transcript attached)


Jake Quinn stated that he has received reports that citizens who believed they were registered at the Department of Motor Vehicles, were told they were not a registered voter when they tried to vote. Director Parker stated she has no indication that this is beyond anything normal. She explained that DMV registration applications are received from the State Board of Elections to our department through state transmission. Steve Holland inquired as to whether the voters whose registration was challenged and then removed from the hearing earlier tonight have the option to vote provisionally. Director Parker stated the provisional voting option is always offered to a voter who cannot, for whatever reason, vote a regular ballot. Chairman Watson added that the voters whose registration was removed tonight have 10 days to appeal the decision.

Rachel Rathbone presented 396 civilian absentee ballots, 14 overseas absentee ballots, and 4 military absentee ballots to the Board. (Attached) All presented ballots were approved by Chairman Watson and Member Smith. The staff scanned the mailed absentee ballots in the 650 scanner. One ballot could not be read by the 650 scanner so a hand-eye count was conducted by a bi-partisan team.

Director Parker informed the Board that a voter believes she was given the incorrect ballot and is requesting to have that vote canceled so she can vote on the correct ballot. Director Parker contacted the State Board of Elections and was advised that the voter's only option is to vote provisionally. Chairman Watson inquired as to how the voter could have received the incorrect ballot. After much discussion and explanation of the

procedure for printing and delivery of ballot to voters, it was the general consensus of the Board and staff that it was highly unlikely that an incorrect ballot was delivered to the voter. Chairman Watson advised Director Parker to investigate the matter further, and if, after further investigation, it appeared that in fact an incorrect ballot was delivered, then to offer the voter a provisional ballot.

The meeting adjourned at 7:53 p.m.
