2	10 NOVEMBER 2015 9:00 A.M.
3	BY MR. WATSON:
4	Good morning everyone, it's nine o'clock,
5	we'll go on the record. I'll call the hearing
6	to order at nine o'clock on November 10th for
7	challenges that have been submitted to the
8	Board of Elections. I know some of you were
9	here at the first hearing that we had. Let me
10	review a few things. First of all, this Board
11	will be proceeding as we're sitting now as a
12	quasi-judicial body. This is not an open
13	meeting. This is not some meeting where you
14	just raise your hand and start speaking. This
15	is a hearing so please respect that. Also, we
16	understand that folks own property in
17	Montreat, some of it's been there in the
18	family for years. They have vested interest
19	in Montreat. Please understand that, in and
20	of itself, is not sufficient to entitle
21	someone to vote in Montreat. The laws in our
22	supreme court for years have set out some
23	guidelines and it's not merely taking an oath
24	that you're a U.S. citizen and not a felon,
25	and those things that have been submitted in

some of the affidavits previously. What we're looking for is to see where is your domicile. By that, domicile and residence aren't necessarily interchangeable for voting purposes. Domicile is that place that you call home, spend your time. Think of it as where would you have most of your family pictures, things that are part of your day-today life. Where's your driver's license registered to. Where do you put on your tax returns for your home, things like that. Reading a few things here from our supreme court, to establish a change in domicile, I think that's relevant here because at least based on some of the information we've received, there's long voting history, long residential history in other places than Montreat for some of you, and now different ones are claiming well, yeah, I understand that but we just recently moved to Montreat. Well, to establish a change in domicile a person must show an actual abandonment of the first domicile, coupled with an intention not to return to it. The acquisition of a new domicile by actual residence and the intent of

making the new residence a permanent home. And I don't mean in the future. I know some folks think well, we're going to retire there someday. Someday when you do retire there, that is your domicile, great, vote. But if that is not currently where you are, your domicile, place that you return to regularly, when business or other matters may take you away, this is where you always come back to as Not vacation place, not someplace you home. might come on a regular basis just for other purposes or to get away, but home. That's what we're looking for. Those are things we're looking for. And if it's not that, then here's an opportunity to say I misunderstood. I was under a different impression. Some have communicated to us. In fact, there was a call this morning into this office. I didn't take it but our director did, from someone who said well, our family's owned this house in Montreat for years and I come up there in the summer and I visit there from time to time for holidays. It's not just do you have an interest in the place. Think about people who own businesses in another county or businesses

1 in another city. Their biggest investment may 2 be somewhere other than where their domicile 3 That doesn't necessarily give them the is. right to go and vote over there. You can have 4 interests elsewhere. You can have a vested 5 6 interest in a community by property ownership, 7 business, many other things. That doesn't 8 necessarily give you a right to vote there. 9 As far as this Board is concerned, and I want 10 to be very clear about this too, we don't know 11 how you registered. The information that we 12 received, before the Board received it we 13 asked the staff to go through and redact any 14 reference to party affiliation. So we don't 15 know what your party affiliation is. We don't 16 know how you voted in the last election. We 17 don't know who your favorite candidates are or 18 who you support. We don't want to know. 19 Please do not reference any of that in any of 20 your comments. We have asked the staff to 21 take any of that information out of our files. 2.2 We have not engaged in conversations along 23 those lines, and we don't want to know. 24 That's not relevant to what we're looking at. 25 What we're looking at is only to see what is

7	BY MR. STRONG:
8	Mr. Chairman, I'm Bill Strong from Montreat,
9	and I am here to represent as the case may be
10	needed the folks who are here. But they are
11	all prepared to testify, themselves.
12	BY MR. WATSON:
13	Okay. Mr. Strong, let me ask you, are you an
14	attorney representing them?
15	BY MR. STRONG:
16	No.
17	BY MR. WATSON:
18	I appreciate you clarifying that. Folks, the
19	statute says it's actually mandatory that a
20	challenge, a registered voter shall appear.
21	If unable, then they may send a
22	representative.

24	Let me just clarify. I am a retired attorney

22	because I own property there, that was enough
23	and I could vote. Anybody who wants to say
24	gee, sorry, that was a mistake, fine, now is a
25	good time to do it. Again let me say, what

2	this, and I don't think anyone on the Board
3	here would have the intent of threatening
4	anyone or making anyone feel uncomfortable.
5	But we do want to let you know that there can
6	be potentially felony implications in this, so
7	we don't say that to scare you. We're just
8	saying folks, understand this is serious. We
9	take it seriously. We have statutory
10	obligations to procedure. I understand that
11	one gentleman had a medical procedure today
12	and I received call, and asked would we
13	postpone it. I'm sorry, we couldn't because
14	it's set by statute. If I'm not mistaken, are
15	you Mr. Reid?
16	BY MR. REID:
17	Yes.
18	BY MR. WATSON:
19	And you're here. I'm sorry, Mr. Reid, I
20	understand you have medical

22	I'm thankful for letting me come.
23	BY MR. WATSON:
24	I'm sorry that the statute sets the time
25	for the hearing and the challenges that we

10 1 have today. 2 BY MR. REID: 3 I understand. 4 BY MR. WATSON: Anything as far as opening from Board members? 5 6 All right. We are going to proceed ---7 BY MR. STRONG: 8 Mr. Chairman, would you permit me to just make 9 a brief statement? 10 BY MR. WATSON: 11 No sir, not at this time I will not. BY MR. STRONG: 12 13 We just wanted to respond to some of the 14 concerns you expressed last time. BY MR. WATSON: 15 16 No, sir. Folks, I appreciate, and I'm not 17 trying to be rude Mr. Strong. Let me also let 18 you know just kind of, I guess a housekeeping 19 matter. This is the day for canvass at the 20 elections. By statute we have to start 21 canvass at eleven o'clock, which gives us now 2.2 a little less than two hours to conduct these 23 11 challenge hearings. We're going to take 24 our time but I'm hoping we can do it before 25 eleven o'clock because if not, then we're

going to have to take a break until we can finish canvass and then come back, and I don't know what time that will be. So I don't think any of you all are wanting to be hanging around all day either. I'm not trying to be rude, Mr. Strong. I know the things that we have to do here this morning. Again this is a hearing and we're going to move forward with it. And we appreciate your understanding. I'm going to call these really in no particular order other than the pile they are in my hands. So first Margaret Bouknight Bauer. Ms. Bauer here? Representative for Ms. Bauer? One more time, Margaret Bouknight I want to note for the record that Bauer. Ms. Bauer's husband was here at the first hearing. He appeared personally. He had testimony before the Board, and the Board asked him a number of questions. There were records from that hearing that would reflect that Mr. Bauer testified under oath that he and his wife have two homes in Montreat, and they also have a home in Columbia. They have a son I believe who's 13 years old, I think was the testimony, 13, 14 years old, who is in

school in Columbia, South Carolina and they 1 2 plan to be there with him in school until he 3 graduates. He was specifically asked why is your son not in school in Owen or some other 4 5 school in Buncombe County if you're claiming 6 that Montreat is your domicile. And his 7 response was to the effect that he's well 8 settled there and we intend to stay there. He 9 gave other testimony which this Board 10 ultimately concluded that he was not a -- his 11 domicile was not in Montreat. Now with 12 regards specifically to Ms. Bauer, two homes 13 as was noted at the first hearing with regards to Mr. Bauer. Ms. Bauer has both homes listed 14 15 on vacation rental by owner and his listed 16 that "we live less than three hours away," 17 which is her reference to Columbia. She also 18 states, "We consider Montreat to be our second 19 home." She has posted that she lives in 20 Columbia, South Carolina. During the flooding 21 in Columbia recently, she put pictures on the 2.2 Web and posted "this was in front of our house 23 today." She's had no prior voting history in 24 Montreat, or Buncombe County I should say. 25 She requests absentee ballots be mailed to her

Columbia, South Carolina, address. Buncombe 1 2 County property cards list her Columbia, South 3 Carolina, address as the address with the register of deeds. It appears they are 4 getting the South Carolina primary home tax 5 6 rate of four percent as opposed to a second 7 home tax rate of six percent. They claim 8 South Carolina as their primary residence for 9 tax purposes. Any other information Board 10 members would like to note? Mr. Keller. 11 BY MR. KELLER: 12 No further questions. 13 BY MR. WATSON: 14 No questions, we'll go to the next file, next 15 Mary Miller Brueggemann. Ms. Brueggemann, if 16 you're more comfortable it's fine if you want 17 to stay at your seat. 18 BY MS. BRUEGGEMANN: 19 I would prefer to sit if I could. 20 (MARY MILLER BRUEGGEMANN SWORN) BY MR. WATSON: 21 2.2 If you'll give us a moment, you submitted an 23 affidavit, give us a moment and we'll read 24 through that. 25 (OFF THE RECORD)

2	Mr. Chairman, I do have a question.
3	BY MR. WATSON:
4	Mr. Strong, please, we're in the hearing and
5	taking testimony from Ms. Brueggemann.
6	BY MR. STRONG:
7	This is germane to Ms. Brueggemann.
8	BY MR. WATSON:
9	Ms. Brueggemann I'm taking testimony from
10	her if you'll let her speak and let us conduct
11	that, I appreciate it, sir. Ms. Brueggemann,
12	thank you for the affidavit. I do have a
13	couple of questions for you, and I'm sure
14	maybe some of the other Board members will as
15	well. I will let them begin if they would
16	like. Ms. Smith, do you have any questions?
17	BY MS. SMITH:
18	Do you claim the Givens Estate home?
19	BY MS. BRUEGGEMANN:
20	No, I have a rental house. I'm 80 years old.
21	I felt last winter that I was having trouble
22	in December when the snows came, and because
23	my twin brother lives there I rented a place.
24	But I applied even in 2009 for it not knowing
25	when I would have to move. My name came up

1	this August is when I read it. But most of
2	the time since August I've been back and forth
3	to Montreat. So basically have two homes. I
4	pay all the bills in both homes. That's
5	expensive but because of my age and my twin
6	brother and his wife, who had Alzheimer's,
7	I've done that. But Montreat is definitely my
8	home. I don't do I do not participate in
9	any activities in Montreat. I noticed that
10	you have the thing from the Highland, I'm sure
11	Tom Johnson gave you that, because you have to
12	do that. You have to be interviewed, and they
13	think it's all wonderful. I just don't go
14	there. All my activities are in Montreat as I
15	told you, I listed some.
16	BY MR. WATSON:
17	Ms. Brueggemann, let me see if I understand,
18	you said you don't do any of the activities in
19	Montreat
20	BY MS. BRUEGGEMANN:
21	No, I meant Highland. Did I say Montreat? My
22	bridge club is in Montreat
23	BY MR. WATSON:
24	That's fine, I just wanted to make sure that
25	you hadn't misspoken. And Ms. Smith just

asked about the Givens Estate. 1 This is not 2 Givens Estate. You're at ---3 BY MS. BRUEGGEMANN: No, but Highland Farms is owned by Givens, so 4 But it's 5 I understood what she was saying. 6 now called Givens Highland Farms. They bought 7 it. Givens is much further away. 8 BY MR. WATSON: 9 Highland Farms, you in one of the little 10 cluster homes ---11 BY MS. BRUEGGEMANN: 12 Right. So I'm allowed seven meals in the 13 dining hall. I've yet to use those seven 14 meals. A month, excuse me. That means I 15 paid it so it's a bit of a problem. 16 BY MR. WATSON: 17 You can rent those homes? 18 BY MS. BRUEGGEMANN: 19 It is technically a rental home. They changed 20 that about two years ago. You used to buy 21 them, now you rent them. And I don't 2.2 understand the tax consequences, because I'm a clergy person somebody's going to have to tell 23 24 me when tax time comes. But in the year 2015, 25 I have spent the majority of my time in

1	Montreat. It never occurred to me. You saw
2	my voter registration, where else would I
3	vote? Even if I thought otherwise, why would
4	I not vote in Montreat?
5	BY MR. WATSON:
6	I'll tell you it presents an interesting
7	question for the Board because, little bit of
8	education here, we're a very transient
9	society, and folks move, people move within
10	the county. They can move within the town.
11	I've moved from one side of Black Mountain to
12	the other side. Our office here, the law is
13	that one of the things we look at is where
14	does someone physically lay their head, and
15	that has been applied very literally. There
16	have been cases where a precinct line has run
17	through a house and the question comes down to
18	where is your bedroom; where do you sleep in
19	the house, which side of the line is that on.
20	If folks knew some of the minute questions we
21	have to sort out, you really wouldn't this
22	is not as clean as we would all like it to be.
23	So it presents an interesting question for us
24	because we understand that you have always
25	been in Montreat, many, many years in

18 1 Montreat, that's your home ---2 BY MS. BRUEGGEMANN: 3 I moved there permanently in 2000 ---4 BY MR. WATSON: You have a long family history there ---5 6 BY MS. BRUEGGEMANN: 7 Yes, I told you about my father buying it. 8 BY MR. WATSON: 9 And about the picture of you as a little girl. 10 BY MS. BRUEGGEMANN: 11 Right. 12 BY MR. WATSON: 13 So you have deep roots there and you moved 14 there, when did you say ---BY MS. BRUEGGEMANN: 15 16 2013. And sold my other house in Decatur, 17 Georgia. 18 BY MR. WATSON: 19 But again it's an interesting question for us 20 because now it appears you may have moved 21 again. So where do you lay your head? That, 2.2 in and of itself, is not determinative either. 23 We have to look at the totality of the 24 circumstances, all the facts. So I want to 25 sort of recap what you've said, and I don't

19 1 want to put words in your mouth. I'm asking 2 you please correct me, add to or take away 3 anything I may misstate here. But is it your testimony before the Board that you still 4 5 consider Montreat your permanent domicile ---6 BY MS. BRUEGGEMANN: 7 Absolutely. 8 BY MR. WATSON: 9 --- that your place in Givens is a rental 10 which you go to ---11 BY MS. BRUEGGEMANN: 12 I've spent the majority of 2015 in Montreat. 13 Most of the month of October I was in Montreat. That doesn't mean I don't come and 14 15 The bedroom in Montreat is just like the qo. 16 bedroom on Wagon Trail. 17 BY MR. WATSON: 18 Where did you spend last night? 19 BY MS. BRUEGGEMANN: 20 I spent last night at Wagon Trail. If that 21 was the requirement in the law, I would have 2.2 gone to Montreat. I actually spent the 23 afternoon in Montreat. I was cleaning house 24 in Montreat in spite of the rain. 25 BY MR. WATSON:

20 1 How about the night before? 2 BY MS. BRUEGGEMANN: 3 I spent it at Wagon Trail, but it does not say that in the statutes. I would have gone up 4 5 there. 6 BY MR. WATSON: 7 We're not requiring that you spent last night 8 in Montreat. But really what we are looking 9 for is where are you spending most of your 10 time. Where are you sleeping? 11 BY MS. BRUEGGEMANN: 12 Most of this year was in Montreat. That 13 doesn't mean ---14 BY MR. WATSON: 15 How about next year where do you intend ---16 BY MS. BRUEGGEMANN: 17 I have not the slightest notion what I'm going 18 to do about next year. I've got to get 19 through the winter. I have steps in Montreat 20 that were very hard for me in the winter when 21 the snows came. And I said to myself, I'm not 2.2 sure, I'm alone. I've got Bay Alarm System; 23 do you know what that is? 24 BY MR. WATSON: 25 No.

1	BY MS. BRUEGGEMANN:
2	It's like Life Alert, because I was frightened
3	and I had my twin brother calling me every
4	morning to make sure I was okay. I have
5	severe arthritis so to go through the winter
6	in Montreat when it's snowing is very
7	dangerous. So that's one of the reason you
8	have to go Highland Farms when they take out,
9	and August was when they took me. But I went
10	back in September, went back in October. I
11	don't know how else to explain it to you.
12	BY MR. WATSON:
13	And I want to thank you for
14	BY MS. BRUEGGEMANN:
15	And let me also say, nobody ever said a word
16	to me about voting. I'm absolutely shocked
17	that this would even come up, because it's so
18	clear that I'm from Montreat. Now whether I
19	voted wrong I don't know.
20	BY MR. WATSON:
21	I don't want to know how you voted. And I
22	don't know that you could vote right or wrong,
23	you have to vote your conscience. But I
24	appreciate also, I want to say thank you for
25	the testimony that you've given us. They are

2.2 1 very helpful and instructive to the Board. 2 Those are the kinds of things that we tend to 3 look for. I have no other questions. 4 Mr. Keller, any questions? 5 BY MR. KELLER: 6 No, thank you. 7 BY MR. WATSON: 8 Ms. Smith? 9 BY MS. SMITH: 10 No, thank you. 11 BY MR. WATSON: 12 Mr. Strong, is there something you feel is 13 burning that needs to be added to this, or are 14 we good to move on? 15 BY MR. STRONG: 16 We'll move on now. 17 BY MR. WATSON: 18 Thank you, sir. Next in my file is Mr. Don 19 Reid. I think it was last Thursday I believe, 20 after the challenge had been filed on -- a day 21 or two after the challenges had been filed and 2.2 before we knew who the names were, challenges 23 came in they were received and we did not 24 receive the names -- I received a call from a 25 friend who is in town and we were chatting

about this that and the other, and there were several things. I was actually standing in line with another person to have lunch, so I said I need to go, and he said before you do I have one other thing I need to bend your ear And he launched into something about the on. hearings and mentioned the Reids particularly. So I said you know -- I was asked at the time could we put it off, Mr. Reid had a medical And I said sorry, I cannot because matter. it's statutorily set. I got off of that conversation as quickly as I could. But because of that, I'm going to recuse myself from the hearings on the Reids because there was a conversation that I got a little ambushed with. I didn't invite it, didn't know it was coming. It was at the opening part of the conversation, but simply because I've had a conversation about this outside of this, and that's essentially I've told you the essence of the conversation. But I don't even want there to be any hint of any problems so I'm going to let Mr. Keller and Ms. Smith at least do the questioning on this and I will refrain from voting on the Don Reid file.

3	If you have information you want to submit you
4	may submit it now.
5	BY MR. REID:
6	Lots of questions they want to ask, and you
7	have answered many of them for us. Primary
8	care physician is in Black Mountain. Members
9	of the racquet club, pharmacy in Black
10	Mountain, official pharmacy. You have a
11	business in Montreat; do you still have a
12	business in Charlotte, Don Reid Associates?
13	BY MR. REID:
14	I sold my business in 2005, and have
15	maintained the name Reid Associates. But I do
16	some work mostly free, my friends expect that.
17	So I do a lot of it, occasionally I've done a
18	little bit of work but not much.

REID: 14 I have a good friend, Michael Dickerson who is 15 the Trena Parker of Charlotte Mecklenburg, and 16 I went to him. I was trying to prevent having 17 to put you through this or me through this, so 18 I did the best I could to try to make sure 19 that I was following the letter and the spirit 20 of the law. So I went to Michael and 21 presented all the stuff that I've given you. And he told me that -- I know he's not the 2.2 23 authority, you are, but I did the best I could to try to prevent -- I know you guys would 24 25 rather not be here, you'd rather be somewhere

8	for a year, so I'm very familiar with what you
9	do, appreciate what you do. I know the
10	difficulty of what you do, and also it's a
11	pretty thankless job. So I was trying to make
12	it easy for all of us, and I hope that this
13	information that I presented will prove that
14	we are residents here. Yes, we have a house
15	in Charlotte and I intend to keep one. We
16	probably will have a smaller house once I'm
17	able to sell the larger house, but you know,
18	it's hard to know where do you live. Well, I
19	lived in Montreat for four years but I haven't
20	really registered to live here. So I feel
21	that legitimately that I've done the best I
22	could to establish a residence and still
23	maintain my residence in Charlotte which I
24	enjoy. We have children there.
25	BY MR. KELLER:

27 1 I understand that. I do wish if I were king for a day, define domicile, define residence, 2 3 define second home, which I think is a phrase that doesn't make any sense. You have a home, 4 lots of houses but only one can be the 5 6 domicile and that's what we're looking for. 7 BY MR. REID: 8 I understand the difficulty. 9 BY MR.
