  - 2021-23 renewal strategies: SJC is working with several partners to develop and implement strategies to reduce community violence. Buncombe County invited to participate in SJC Racial Equity Cohort grant of \$500,000 over two years split between the County and a community partner. The goal of the grant is to support community violence prevention efforts and to reduce failure to appear.
