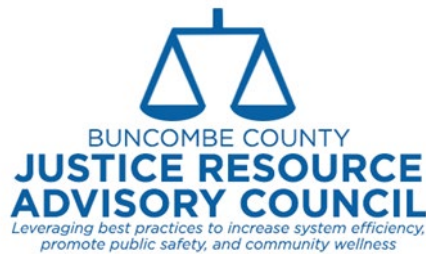

Pat Freeman motion to accept Agenda and Minutes, Sam Snead second; those in attendance approved.

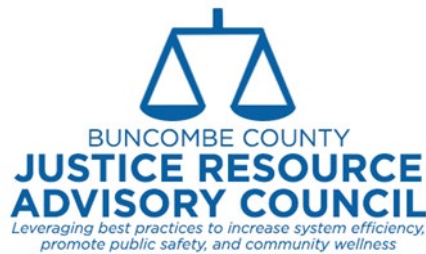
