The Board recessed at 10:56 a.m.


The Board reconvened at 3:10 p.m.

The Board began opening absentee ballots and Jennifer Sparks scanned the ballots into the 850 machine to be added to the totals.


Jennifer Sparks ran the one-stop totals report and the Board signed off on the results.
