The scheduled meeting of the Buncombe County Board of Elections was called to order at 6:30 am November 7, 2017 at 77 McDowell Street, Asheville, NC 28801.

Item One – Minutes

- Chairman Watson motioned to approve the minutes of October 24rd, 2017, Secretary Smith and Board Member Keller seconded, and a motion passed unanimously.
- Chairman Watson motioned to approve the minutes of October 31th, 2017, Secretary Smith and Board Member Keller seconded, and a motion passed unanimously.
- Chairman Watson motioned to approve the minutes of November 4th, 2017, Secretary Smith and Board Member Keller seconded, and a motion passed unanimously.

Item Two - Absentee
