EXCELLANCE IN SERVICE

• Gibbie Harris recognized all the staff that worked so diligently during the recent salmonella outbreak. The work done was recognized by receiving an award for "Best Practice in an Outbreak Response" during the Communicable Disease Conference held in Raleigh. Gibbie Harris shared that the work done is one of great teamwork by the staff at the Buncombe County Dept. of Health. There is a poster placed on the wall that outlines the beginning steps through the process of work that was done. This poster was also presented at the conference that the Disease Control Staff attended.

INTEGRATION INITIATIVES

Nelle Gregory introduced Melissa Baker the Innovative Approaches Coordinator.

- Innovative Approaches held a panel discussion and presented a PowerPoint of the program that is
 a system to improve the Care for Children with Special Health Care Needs. The panel
 spokespersons included Melissa Baker-Health, Becky Kessel-DSS, Alice Elio-Health, Dr. Harold
 Kowa-Blue Sky Pediatrics, Jackie Latek-Families Together, Kathryn Brewer-Parent and Sherry
 Noto-RN.
- The social work and community health collaboration covers services provided by Child Protective Services, Nurse Social Work Teams, Nurse Family Partnership and the Under Six program.
- Kathryn Brewer spoke as a parent representative about how the IA program has changed her life in the way that she now gets to attend conferences and trainings on how to navigate services for her child with special healthcare needs.
- Dr. Kowa shared that as a physician the IA program has piloted to support standard protocols for supporting youth transition to adult health care when the patient ages out to adulthood and needs different services. Currently there are practices that collaborated with evidence based protocols for asthma, ADHD and Obesity. They are MAHEC, CCWNC and Asheville Pediatric Associates, Blue Sky Pediatrics, Mountain Area Pediatrics.
- Alice Elio talked about the collaboration with the schools. There are school health forms that
 have been placed on a CD for pediatric providers, school nurses have been placed onto the
 transition teams for students with special healthcare needs.
- Jackie Latek discussed the behavioral health end of the IA program that deals with teens in foster care that transition to an adult care home. Training is provided for both the youth and the families.
- Becky Kessel talked about the community collaboration end that deals with support to families
 that cannot find an adult medical home. She also shared a link to www.youfindservices.org which
 was developed as a searchable website of services in Buncombe County for children and youth
 with special healthcare needs.
- The future efforts are to work more with transitioning to adult living, family needs for non-English speaking families and supporting the future work of IA for continuing efforts.
- This program is unique as it is the only comprehensive system focused on the special healthcare needs population of youth in our area, a strong parent and physician collaboration and it continues to grow. A copy of the PowerPoint and hand out is attached and made a part of these minutes.

INTEGRATION UPDATE: HB438
