BUDGET FY13 FINANCIALS

Jim Holland went over the FY14 financials with the Board. A copy of the financial dashboard and the PAR are attached and made a part of these minutes. He then reported on the approval of new Income Maintenance Caseworker and Nurse Family Partnership positions by the Board of Commissioners. Jim stated that the Buncombe County Commissioners recently approved the addition of 12 Income Maintenance Caseworkers (IMC) and 5 Income Maintenance Supervisors. The IMC request was made as a result of the implementation of NC FAST. The additional staff will support the requirement of NC Fast and assure that timely and accurate benefits are issued to citizens of Buncombe County. Regarding the Nurse Family Partnership positions the state recently approved a grant application by BCHHS for additional funds to support the Nurse Family Partnership program. The additional funds provide support for 3 new Public Health Nurses and 1 Office Assistant. These positions will allow us to serve additional families in this evidence-based model that has proven to reduce the incidence of child abuse and neglect.
