- The Chairperson asked if any Board member had any known conflict of interest or appearance of conflict with respect to any matter coming before the Board and none were stated.
- The Board reviewed the May 30, 2014 Board minutes. Board member Richard Oliver motioned that the minutes be approved as presented. Board member Stephanie Kiser seconded the motion and the vote was unanimous in approval.

## COUNTY BEHAVIORAL HEALTH INITIATIVE

Rich Munger introduced the presentation about HHS behavioral initiatives by showing a
brief video about how persons with mental illness are defaulting into the criminal justice
system and jail because of the lack of psychiatric hospital beds and community services.
He then introduced community partners who contract with HHS to fill critical gaps in
behavioral health services.

- Amy Griffith of RHA Health Services spoke about jail diversion programs, including Crisis Intervention Team (CIT), reentry services at the jail, and the three problem-solving courts: Drug Court, Family Treatment Court, and the new DWI Court.
- Amy Johnson, a licensed professional counselor at RHA, who talked about the Assessment Center program. Two fulltime evaluators provide comprehensive clinical assessments for HSS Social Work clients, as well as other court-involved clients. RHA has begun to gear up to provide assessments in more complex cases where parenting capacity issues are foremost.
- Brian Alexander, Executive Director of Homeward Bound of WNC, discussed efforts to serve chronically homeless persons in Buncombe County. By providing supportive housing to chronically homes individuals over the past 8 years, they have reduced chronic homelessness by close to 90%. The Asheville-Buncombe Homeless Initiative Advisory Committee has been working with a local developer to build a 30-unit apartment for this group, modelled after Moore Place in Charlotte. The program, called Oak Hill Commons, would include 24 hour security and services on-site by local providers.
- Don Collins, who is formerly homeless and now working as a peer support specialist with Homeward Bound. He shared his personal experience with homelessness and how supportive housing helped him get on the path to recovery. A copy of the PowerPoint is attached and made a part of these minutes.

#### ADVISORY COMMITTEE REPORTS

- Phillip Hardin presented highlights on the Economic Services Committee. Presentation by Board member Rick Elingburg who works with the Employment Security Commission about the transformation of the Employment Security Commission. They have evolved into a job training facility.
- Stephanie Kiser presented highlights on the Public Health Advisory Committee. Buncombe County is one of 6 counties in the nation that has been recognized and received the Culture of Health prize by the Robert Wood Johnson Foundation. Stephanie's presentation highlighted the socio economic functions impacting health and how every organization/individual in our community is a part of our "health culture". September 26<sup>th</sup> will be a collective community celebration at the Wilma Sherrill Center.
- Angie Pittman presented on the Social Work Advisory Committee. This committee is currently
  focused on placement stability. One strategy she highlighted was a partnership with Mission to
  recruit within Mission for foster homes with special medical needs to care for medically fragile
  children.
- Frank Castelblanco presented on the Community Advisory Committee. Frank asked Senator VanDuyn to speak about her meeting with the Community Advisory. Senator VanDuyn hosted a "Town Hall" forum for consumers. At the last meeting of the Community Advisory (ABCRC) Asheville Buncombe Community Relations Council presented on their anti-discrimination program.
