Justice Center opened its doors to survivors of domestic and sexual violence. Representatives from
onsite agencies shared information about services provided at the FJC in its first year and stories of
how victims of domestic and sexual violence have accessed services at the FJC.

Since the FJC opened, survivors of domestic and intimate partner violence have accessed counseling, civil legal services, safety planning, sexual assault medical exams, education, and criminal justice support from agencies located at the Family Justice Center. Onsite Partners include: Asheville Police Department, Buncombe County Health and Human Services, Buncombe County Sheriff's Office,
