- Immunization rates were published and Buncombe County exemption rate is the highest in North Carolina. Dr. Mullendore has been point person for highlighting importance of childhood immunizations.
- Jackie Kiger with Pisgah Legal Services spoke to the Board on open enrollment for the Affordable Care Act.
- Fletcher Tove shared with the Board about Veterans History Awareness Month.

PROGRAM UPDATES – ADOPTION AWARENESS

 Tammy Shook introduced Rebecca Smith and Angie Garner. Some employees of the Foster Care and Adoption unit were in attendance and were introduced. Rebecca Smith and Angie Garner presented a Foster Care and Adoption PowerPoint to the Board. November is Adoption Awareness Month. A copy of this PowerPoint is attached and made a part of these minutes.

NEW BUSINESS

- Board Chair Susanne Swanger asked Board attorney Brandon Freeman to conduct the election of officers. Mr. Freeman asked if any Board Members had any objections to him conducting the election of officers. None were raised.
- Mr. Freeman shared the Executive Committee's recommendations according to the
 process outlined in the Board Operating Procedures that Board Chair Suzanne Swanger
 continue to serve as Board Chair and that Board Member Frank Castelblanco be
 appointed Vice Chair because the current chair, Richard Oliver, desired to transition out
 of the role but remains on the Executive Committee.
- A motion was made by Board Member Terry VanDuyn nominating Board Chair Susanne Swanger for Board Chair. The Motion was seconded by Board Member Jacquelyn Hallum and the motion passed unanimously.
- A motion was made by Board Member Ellen Frost nominating Board Member Frank Castelblanco for Vice Chair. The Motion was seconded by Jacquelyn Hallum and the motion passed unanimously.
- Mr. Freeman reported to Board Chair Swanger that she had been elected Board Chair and that Board Member Frank Castelblanco had been elected Vice Chair. Mr. Freeman recommended that the Board ratify the vote out of an abundance of caution. Board Chair Swanger moved to ratify the vote. The Motion was seconded by Board Member Ellen Frost and passed unanimously.
- The Health Division Director addressed the board, providing recommendation that the board amend local HHS Board rule 2016-01, which adopted the guidelines for rabies post-exposure management specified by the National Association of State Public Health Veterinarians (NASPHV) in October of 2016. The reason for the amendment was to repeal this local rule, as the General Assembly adopted said guidelines in June of 2017 and the local BOH Rule became redundant. Chair Swanger asked for a motion which was provided by Board Member Jacquelyn Hallum and a second provided by Board Member Terry VanDuyn. There was discussion and subsequently, the board approved the resolution and local Rule 2016-01 was repealed.
