Dear Mr. Creighton:

As you know there is a new industrial park (Ferncliff Park) under development on the west side of the Asheville Regional Airport. The first industry, Sierra Nevada Brewing Company, to locate in the park is well under construction and expects to be in production within the next few months.

The access road to this park is a State maintained road – Old Fanning Bridge Road (SR # 3526) which makes a sharp turn at the entrance to the park. A new road within the park, Ferncliff Park Drive, has been constructed by NCDOT and will be opened to the public in July.

The developer of the industrial park (Brightstar Associates, Inc.) and Sierra Nevada Brewing Company would like to request that the name Ferncliff Park Drive be extended the entire length out to the NC Hwy 280 intersection (see attached map). This request would impact a section of the existing Old Fanning Bridge Road.

Enclosed for review and processing please find a Road Name Petition form with signatures from the adjacent property owners which would be impacted by this change. Also enclosed are resolutions of support from the Town of Mills River and the Town of Fletcher. The corporate boundaries of these municipalities touch this section of the roadway.


