### **KEY HEALTH AND SOCIAL SERVICES DATA/ISSUES BRIEFING:**

Ms. Harris shared with the Boards the 2011 Buncombe County Health Report. The community health priorities were developed by a group of community partners that attended meetings over the past year or longer. These priorities are; Improving Women's Health During Childbearing Years, Promote Healthy weight and Healthy Living, Improve Children's Health Outcomes through a Focus on Family Support and Education, Increase

Readiness of all Children to Learn and Succeed in School and Access to and Continuity of a Mental Health and Primary Care Home.

Ms. Harris discussed both the strategies and outcomes for each priority and the community partners that will be sharing in those areas to make strides in reaching goals.

Ms. Warren with DSS shared information on the 2011 Child Protection Team Annual Report.

Ms. Pittman with DSS shared information about "Sight on Six" A Community Response to Protecting Children. This report showed national data concerning young victims of fatalities by age, race and gender. Buncombe County data child fatalities between 2003 and 2011 show an age of 1-3 yrs was at 58.8%, 4-7 yrs at 28.5%, 8-11 yrs at 11.8% and 12-15 yrs at 5.9%. Males were 59% compare to females at 41%.

Moving forward as a community will involve education on abuse, intervention and prevention. Sight on Six is a specific campaign related to ensure safety of children under the age of six.

# DEVELOPING AN INTEGRATED RESPONSE

The board members worked with groups of various Health and Social Services staff on topics of Increasing Immunization Rates, A Community Response to Protecting Children and Promoting Healthy Weight and Healthy Living. The work groups gathered ideas and how to put those ideas into plans on each topic as to how the goals can be reached.

Mr. Jerry Rice gave a public comment. He suggested that the county tap into resources that are free. He also inquired if the county has ever done a poverty study and is there a job study in place.
