

2 FACILITIES IN ASHEVILLE/BUNCOMBE
THE DIVISION OF HEALTH SERVICE REGULATION LICENSES AND MONITORS
THESE HOMES

- 1. RIVERVIEW 6 BED FACILITY IN WEST ASHEVILLE FOR MEN AND WOMEN- GROUP LIVING LOW, SUPPORTED WITH STATE FUNDS FROM WHN
- 2. BILTMORE HOUSING, INC. 6 BED FACILITY IN ARDEN FOR MEN AND WOMEN, TRANSITIONAL STAY FOR 6 MONTHS

FACILITIES ARE STAFFED
24/7 WITH OVERNIGHT ASLEEP STAFF

#### **Adult Care Homes**

ADULT CARE HOMES HAVE 7 OR MORE BEDS

THERE ARE 22 FACILITIES IN ASHEVILLE/BUNCOMBE A TOTAL OF 885 BEDS

FACILITIES ARE STAFFED 24/7 WITH OVERNIGHT ASLEEP STAFF

#### **Family Care Homes**

FAMILY CARE HOMES HAVE UP TO 6 BEDS

THERE ARE 65 FACILITIES IN ASHEVILLE/BUNCOMBE A TOTAL OF 386 BEDS

#### **Transitional Homes**

BILTMORE HOUSING, INC. ESTABLISHED IN 2011
PROVIDES UNLICENSED TRANSITIONAL HOUSING IN
4 FACILITIES IN ASHEVILLE CITY
A TOTAL OF 20 BEDS

TENDS TO HAVE OPENINGS
DUE TO TRANSITIONAL STAY

FUNDS: RESIDENTS PAY \$20 PER NIGHT; UTILIZE FOOD STAMPS

WNC HOUSING, INC. HAS 16 APARTMENT BUILDINGS/HOMES THAT HOUSE A TOTAL OF 63 INDIVIDUALS WITH SERIOUS MENTAL ILLNESS

FIRST PROPERTY BUILT IN 1984, LAST PROPERTY BUILT IN 2007

FUNDS: HUD/NCHFA COVERS RENT/UTILITIES

### DHHS Targeted Housing Program (Key Housing)



THERE ARE 8 APARTMENT BUILDINGS IN ASHEVILLE/BUNCOMBE THAT HAVE UNITS FOR INDIVIDUALS/HEADS OF HOUSEHOLD WITH DISABILITIES

INDIVIDUALS/HEADS OF HOUSEHOLD ARE REFERRED BY REFERRING AGENCIES (MH PROVIDERS) APPROVED BY DHHS

REFERRAL AGENCIES ARE CALLED BY LEAD AGENCY STAFF IF ISSUES ARISE FOR TENANTS. REFERRAL AGENCY STAFF ARE EXPECTED TO RESPOND.

FUNDS: INDIVIDUALS/HEADS OF HOUSEHOLD MUST HAVE DISABILITY INCOME/KEY RENTAL ASSISTANCE COVERS REMAINING RENT COSTS

#### Oxford House



7 OXFORD HOUSES IN ASHEVILLE/BUNCOMBE 17 BEDS FOR WOMEN/35 BEDS FOR MEN

FOR INDIVIDUALS IN RECOVERY FROM SUBSTANCE ABUSE

NO LIMIT ON STAY

EACH HOME HAS A LEAD RESIDENT. REGIONAL OXFORD HOUSE STAFF CAN RESPOND TO TENANT ISSUES.

INDIVIDUALS PAY RENT AND MUST FIND EMPLOYMENT WITHIN FIRST 2 WEEKS OF STAY

## Institutions for Mental Disease (IMD) Assessment Process

FACILITIES WITH 17 OR MORE BEDS ARE BEING ASSESSED BY THE STATE MEDICAID AGENCY, DIVISION OF MEDICAL ASSISTANCE, TO SEE IF 50% OR MORE OF THEIR RESIDENTS HAVE A DIAGNOSIS OF MENTAL ILLNESS.

IF A FACILITY MEETS THIS CRITERIA, THEN DMA CONDUCTS AN ON-SITE REVIEW TO DETERMINE IF THE FACILITY MEETS THE CRITERIA OF AN IMD.

A FACILITY IS CONSIDERED AN IMD IF ITS OVERALL CHARACTER IS THAT OF A FACILITY ESTABLISHED AND MAINTAINED PRIMARILY FOR THE CARE AND TREATMENT OF INDIVIDUALS WITH MENTAL ILLNESS, WHETHER OR NOT IT IS LICENSED AS SUCH A FACILITY.

MEDICAID WILL NOT COVER THE CARE AND TREATMENT OF INDIVIDUALS PLACED IN IMDS.

## Institutions for Mental Disease (IMD) Assessment Process

THE ASSESSMENT PROCESS IS CURRENTLY IN PHASE II.

IN PHASE I, 3 ADULT CARE HOMES IN ASHEVILLE/BUNCOMBE WERE DETERMINED BY DMA TO BE IMDS:

CANTERBURY HILLS

AVALON HILLS

CANDLER LIVING CENTER

A TEMPORARY RESTRAINING ORDER WAS ISSUED AND LATER EXTENDED WHICH STALLED THE DETERMINATION PROCESS.

THESE FACILITIES ARE NOW IN PHASE II OF THE ASSESSMENT PROCESS.

## Institutions for Mental Disease (IMD) Assessment Process

AN INJUNCTION WAS GRANTED IN EARLY OCTOBER 2012
REGARDING SOME FACILITIES DETERMINED TO BE IMDS – THE
STATE OF NORTH CAROLINA WILL PROVIDE 100% OF MEDICAID
FUNDS TO SUPPORT INDIVIDUALS IN THESE FACILITIES.

THIS INJUNCTION WILL MOVE TO A HEARING IN EARLY 2013.

THE EXPECTATION IS THAT AS ADDITIONAL FACILITIES ARE DETERMINED TO BE IMDS, THEY TOO WILL TAKE THIS ISSUE TO COURT AND WILL BE ISSUED THE SAME OUTCOME – TEMPORARY RESTRAINING ORDERS LEADING TO INJUNCTIONS.

### Department of Justice Settlement Agreement

RESULT OF COMPLAINT TO THE FEDERAL DEPARTMENT OF JUSTICE BY DISABILITY RIGHTS, NC IN JULY OF 2010.

FEDERAL AND NC STATE GOVERNMENTS CAME TO AN AGREEMENT IN JULY OF 2012. NC IS IN THE PROCESS OF DEVELOPING THE IMPLEMENTATION PLAN FOR THIS AGREEMENT.

THE PLAN FOR THE AGREEMENT WILL START IN FEBRUARY 2013.

### Department of Justice Settlement Agreement



WHAT DOES THE AGREEMENT LOOKS LIKE?

- 1. COMMUNITY BASED SUPPORTIVE HOUSING "HOUSING SLOTS"
- 2. COMMUNITY BASED MENTAL HEALTH SERVICES ASSERTIVE COMMUNITY TREATMENT TEAMS, SUPPORTED EMPLOYMENT SERVICES
- 3. IN-REACH WHN STAFF TO MEET WITH ADULT CARE HOME RESIDENTS AND INDIVIDUALS IN STATE HOSPITALS TO INFORM THEM OF COMMUNITY BASED HOUSING OPTIONS
- 4. DISCHARGE & TRANSITION EFFECTIVE STATE HOSPITAL DISCHARGE PLANS AND ADULT CARE HOME TRANSITION PLANS WILL BE DEVELOPED
- 5. PRE-ADMISSION SCREENING AND DIVERSION FOR INDIVIDUALS BEING CONSIDERED FOR ADULT CARE HOME PLACEMENT; ASSESS FOR SERIOUS MENTAL ILLNESS AND REFERRAL TO WHN
- 6. QUALITY ASSURANCE AND PERFORMANCE IMPROVEMENT STATE WILL MONITOR PLACEMENTS AND SERVICES ARE DEVELOPED IN ACCORDANCE WITH THIS AGREEMENT
