RESOLUTION AUTHORIZING THE SUBMITTAL OF INFORMATION RELATED FOR THE JUVENILE CRIME PREVENTION COUNCIL PROGRAM FOR FY 2009 TO THE NORTH CAROLINA DEPARTMENT OF JUVENILE JUSTICE AND DELINQUENCY PREVENTION

- WHEREAS, the Board of Commissioners desires to have an impact on delinquent and at-risk youth in Buncombe County; and
- WHEREAS, Buncombe County has received funding for the past 25 years from the North Carolina Department of Juvenile Justice and Delinquency Prevention (DJJDP) for this purpose; and
- WHEREAS, the Board has appointed the local Juvenile Crime Prevention Council (JCPC) to identify unmet needs, monitor funded programs, and review and recommend funding for local programs and projects designed to reduce the number of youth who enter the state's youth development centers; and
- WHEREAS, the JCPC will submit certification standards, Bylaws, budget information, contract for professional services, and the proposed membership for Board approval prior to submission to the NC DJJDP; and
- WHEREAS, additional funds have been received and programs have applied for these additional funds mid-year; and
- WHEREAS, the Board of Commissioners feels that it is in the best interest of the County to approve the submittal of these materials for FY 2009.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS FOR THE COUNTY OF BUNCOMBE AS FOLLOWS:

1. That the materials are approved and can be submitted to the NC DJJDP.
2. That the County Finance Director and Chairman be and are hereby authorized to execute contract documents with the NC DJJDP.
3. That the County Finance Director and Chairman be and are hereby authorized to execute other documents associated with this project as necessary to carry out the project.
4. That this Resolution shall be effective upon its adoption.

CURRENT STATUS:

Each year the County receives funding through the NC Department of Juvenile Justice and Delinquency Prevention. This year, \$519,004 was made available to the County to support Juvenile Crime Prevention Council programs. The JCPC recently received an additional \$15,800. As part of the requirements of receiving funding, certain materials are required to be approved by the Board and submitted to the NC DJJDP.

BACKGROUND SUMMARY:

The Juvenile Crime Prevention Council (JCPC) has approved the materials to be submitted. The Board must approve these materials prior to submittal to the NC DJJDP.

COMMUNITY IMPACT/INQUIRIES:

There is potential and likelihood for youth to receive assistance and programming that may deter them from committing further crimes.
