Quarter 1	In Q1 Consulta Tu Compa provided resource and referral support to 33 Latinx community members in crisis, connecting them with service providers and legal assistance. We also provided more intensive accompaniment for 6 people, going with them to court or to access services from local agencies where interpretation was not provided by the agency. We later followed up to ensure issues were being resolved as well as possible.
Quarter 2	In Q2 Consulta Tu Compa provided information, resources and referral support to 25 Latinx community members in crisis, connecting them with service providers and legal assistance. We also provided more intensive accompaniment for 2 people, going with them to court or to access services from local agencies where interpretation was not provided by the agency. Coordinator continues to follow up with cases that are still ongoing. Consulta Tu Compa also supported 3 Community Food Distribution Markets (Oct, Nov, Dec).

Quarter 3	<p>In Q3, Consulta Tu Compa hired a new member to support the program. CTC provided information, resources and referral support to 25 Latinx community members in crisis, connecting them with the appropriate resources and referrals to legal assistance. CTC conducted 1 home visit and supported 3 individuals with accompaniment. Members of CTC attended the WISH Collaborative through Land of Sky to collaborate on housing issues for the elderly Latinx population. During this quarter, CTC attended the BCPEA meeting with Buncombe County and the WNC Rural Immigrant Services Collective Monthly Meeting. CTC collaborated with On Track, Nurse Family Partnership, AB Tech, Bounty and Soul, and MANNA FoodBank. CTC hosted 5 "Meet and Greets" this quarter: One with Carolina Small Business Organization for Latinxs entrepreneurs in February. Another one with Our Voice about sexual violence education. We had 3 Community Food Markets where provider "Meet and greets" took place, the following agencies were invited to provide resources for the community: YMCA, UNETE, On Track, Maximus, Migrant Program, AB Tech, Carolina Small Business, Energy Savers, Land of Sky, and Buncombe Partnership for Children. CTC tabled for 2 events this quarter, one at Erwin Middle for their Community Nights through United Way. CTC was also invited to table during the Mexican Consulate on Wheels that the YMCA hosted the week of March 20-24th. Lastly, the CIMA team had the privilege of traveling to Atlanta to learn about The Georgia Latino Alliance for Human Rights (GLAHR) and the services they provide for their community. CTC collaborated with their hotline team to learn about their program.</p>
Quarter 4	<p>In Q4, CTC provided information, resources and referral support to 30 Latinx community members in crisis, connecting them with the appropriate resources and referrals to legal assistance. CTC conducted 1 home visit and supported 6 individuals with accompaniment to court, school, and DMV. CTC hosted 2 Wellness Workshops which included a Chiropractor sharing tools to use at home and an Accupuncturist who provided a session that focused on the NADA protocol (ear) to support with anxiety and depression. CTC partnered with OnTrack and Bounty and Soul Latino and held a community event about financial literacy. During this quarter, CTC tabled 1 community event at Eblen Intermediate School and co-facilitated a "Darkness of Light" session with Verner Learning Center. CTC collaborated with the following agencies: AB Tech, Asheville Humane Society, Church World Service, Pisgah Legal Services, Land of Sky, Children First, and BeLoved. In June, we recorded a conversation in Spanish with Mercy with "Our Voice" about their services and sexual abuse, the video had 764 views on Facebook. CTC staff attended a workshop through Tzedek about social justice and attended the SEIRN Conference in Alabama that focused on mental health. CTC lead the Community Market with Manna Foodbank every month this quarter where 2,223 individuals were able to have access to food in Buncombe County.</p>
