
The meeting was called to order at 5:31 p.m. Member Smith moved to approve the minutes of April 22<sup>nd</sup>. The motion passed.

The Board examined the absentee applications presented by Rachel Rathbone. Member Smith moved to approve the applications on the list as submitted. The motion passed. (Attached)



The Board prepared absentee ballots for counting. The ballots were scanned in the 650 scanner and the disc was secured for Election Day reporting.



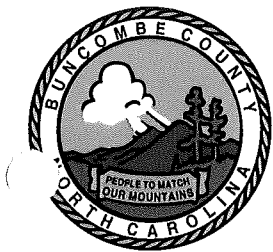

Dear Voter:

This letter is to address two concerns which have arisen regarding voter registration and voting location for residents of Montreat. First, recently a mailing from the Board of Elections alerted voters in Montreat to a change in their voting location and listed the Election Day voting location as Anderson Auditorium, Black Mountain. The location was noted as a Black Mountain address due to the residential zip code assigned by the U.S Postal service. To clarify the location, **if you are a voter whose registration shows a residential address within the (36.1) Montreat precinct, you will vote on Election Day at the Anderson Auditorium located inside the town of Montreat.**

Second, the same reason which caused confusion over the location of Anderson Auditorium has likewise raised questions regarding the voter registration of residents of Montreat. By law a voter must vote in the precinct of the voter's residence. A voter's residence is generally defined as "that place ... in which that person's habitation is fixed ... and to which that person has the intention of returning" and has been described as that established or permanent location "where the voter lays his or her head." The zip codes for residential locations are established by the US Postal Service and those zip codes are used by the Buncombe County GIS Department. In the case of Montreat residents, the residential locations of voters, i.e., voters' homes within the town of Montreat, have been assigned a Black Mountain zip code. Consequently, for voter registration purposes the records of the Board of Election must show the postal designation, Black Mountain 28711, although the residential street name and number may be located within the Montreat municipality. However, for voter mailing purposes, a Montreat residence may use their Montreat PO Box number with the Montreat 28757 zip code. Under North Carolina General Statute, verification of a voter's registration is made by U.S. Postal mail delivery. Please be advised that the Board of Elections is aware that Montreat residents receive US mail service at their respective PO Boxes, and we will use the PO Box mail address, or other mailing address as provided by the voter on their registration card, for communication purposes. To summarize, the listing of a Montreat voter's residence as a Black Mountain address is for registration purposes due to the combination of voter registration laws and the zip code assignments of the US Postal Service and Buncombe County GIS Department; for mailing and communication purposes, the BoE will use the voter's Montreat PO Box or other mailing address provided by the voter.

Enclosed is a map which highlights Anderson Auditorium, and illustrates that a number of residents who might be considered Montreat residents do not actually live in the town of Montreat, and that there are no geographic boundaries for the 28757 zip code. We hope this clarifies any confusion regarding these issues, and we thank you for your interest and concern for the voting process.
