The meeting was called to order at 5:30 p.m.


Secretary Knapp motioned to approve the minutes of October 21, 2014. The motion passed unanimously.


Chairman Watson has generated a letter requesting that groups who are planning to perform and/or recruit musicians to perform outside of early voting sites to cancel any such plans as it will interfere with the voting process. (Attached) Secretary Knapp expressed a desire that the letter be more strongly worded. Chairman Watson entertained a motion to approve the letter to be sent to both party chairs. Secretary Knapp motioned to approve. The motion passed unanimously.


Rachel Rathbone presented 255 civilian absentee ballots, 9 overseas absentee ballots, and 3 military absentee ballots to the Board. (Attached) The staff scanned the mailed absentee ballots in the 650 scanner. Three ballots could not be read by the 650 scanner so a hand-eye count was conducted by a bi-partisan team. Two presented ballots were approved unanimously by the Board, one ballot was approved on a 2 to 1 vote.

Secretary Knapp expressed he would not be able to attend the challenged voters hearing next Tuesday but shared with the Board his approval to remove the challenged voters in the absence of contrary evidence.

Secretary Knapp moved to adjourn the meeting. The motion passed unanimously. The meeting adjourned at 6:30 p.m.
