THE BUNCOMBE COUNTY BOARD OF ELECTIONS MET ON OCTOBER 12, 2015 AT 5:30 P.M., AT 77 MCDOWELL STREET, MAIN LOBBY, IN ASHEVILLE NORTH CAROLINA, WHERE AND WHEN THE FOLLOWING BUSINESS WAS TRANSACTED:

The meeting was called to order at 5:30 p.m.

The Board reviewed the minutes of October 6, 2015. Member Keller moved to approve the minutes. The motion passed unanimously.

John Noce presented to the Board 7 absentee applications, 5 civilian and 2 overseas, that came in after Election Day but within the statutory timeframe to be accepted (G.S. 163-231(b)(2)). All ballots were approved unanimously by the Board. (Attached)


John Noce presented to the Board 3 absentee applications that were returned undeliverable. Mr. Noce attempted to contact these voters but did not receive a response. Mr. Noce also presented 7 absentee applications that were received by the statutory deadline but were missing a postmark (G.S. 163-231 (b)(2)). Member Keller moved to disapprove the 10 absentee applications. The motion passed unanimously.

The Board unanimously approved the supplemental absentee abstracts and the results were sent to the State Board of Elections.



The Board reviewed the ballots. Member Keller moved to approve the 17 ballots recommended for approval. The motion passed unanimously. Member Keller moved to disapprove the 11 ballots recommended for disapproval. The motion passed unanimously. (Attached)

Director Parker presented to the Board 17 challenged voters. The Board tentatively set a preliminary hearing for October 16th at 11 a.m. The Board set a full hearing tentatively for October 27th. The final date and time of the respective challenge hearings will be determined by the Board at the October 13 meeting.
