## **Courthouse Drainage Improvements**

The approval for funding of the Courts Complex chiller was given with the FY19 budget. In order to proceed with the addition of the chiller, the existing storm water drainage manhole must be relocated. After surveying the area adjacent to the facility, the only feasible option is to locate the new chiller where the manhole is currently located. The manhole will be moved to a more appropriate location as well.

The design was completed by a civil engineer and three bids were received with pricing in accordance to our estimated budget.
