### **INVOCATION**

# **GOOD NEWS**

• Tax Assessment awarded "Certificate of Excellence in Assessment Administration"

Keith Miller, Tax Assessor, explained the award that was given by the International Association of Assessing Officers (IAAO). He also acknowledged the staff members that participated in the project that earned the award and stated the project promoted teamwork within the department.

## **PRESENTATIONS**

Tourism Management and Investment Plan (TMIP) Update

Stephanie Brown, of Tourism Management Authority (TDA), presented information about the TMIP and how investments have been made through community projects. The TMIP is a project that has a ten-plus year investment strategy with the TDA, City of Asheville and Buncombe County being key partners. The process will be inclusive as to garner feedback from the neighboring towns.

## **COUNTY MANAGER'S REPORT**

Avril Pinder, County Manager, asked for an update on the RAB Builders and the Board of Adjustment settlement from Michael Frue, Senior Staff Attorney.

Mr. Frue stated that through mediation the claim was settled for \$200,000 and suggested that it would have been less than potential attorney's fees.

#### **NEW BUSINESS**

## Resolution Authorizing Technical Correction for Contracts Policy

Michael Frue, Senior Staff Attorney, explained that the resolution eliminate the discrepancy between the Procurement Manual and the Contract Policy that allow the County Manager to enter into contract.

Commissioner Belcher moved to authorize the technical correction as presented. Commissioner Edwards seconded and the motion passed 7-0.

## Resolution Authorizing the County Manager to Enter into a Lease with the City of Asheville for the East Asheville Library

Jim Blanton, Library Director, stated that the lease agreement fee from the City of Asheville is \$1/year for 99 years. The County will be responsible for improvements to some exterior areas, such as the basketball court, playground and pedestrian crossing.

Don Yelton asked how much does each library costs and how many people does each serve.

Commissioner Belcher moved to accept the resolution as presented. Commissioner Whitesides seconded and the motion passed 7-0.

## • Rules and Procedures for Board of County Commissioners

Chairman Newman explained that the origination of the conversation surrounding the changes to the rules and procedures started with the interest of moving and changing the public comment session within the meeting. The Commissioners provided their perspective on some of the changes and agreed to delay any decisions until more thought and understanding could be included.

### **BOARD APPOINTMENTS**

Commissioner Belcher moved to reappoint **Alan Lang** to the **Agricultural Advisory Board for Farmland Preservation**. Commissioner Pressley seconded and the motion passed 7-0.

Vice Chair Beach-Ferrara moved to reappoint **Michael Fisher** and **Julie Goodman** to the **Crime Stoppers Board of Directors**. Commissioner Whitesides seconded and the motion passed 6-1. (NOES-Belcher)

## **PUBLIC COMMENT**

Don Yelton expressed his concern with the public comment session moved to the beginning of the meeting and questioned some of the policies and procedures of the board meeting.

Jerry Rice stated that the commissioners talk too much and don't listen enough. He also suggested that the Board talk about real things and not just politics.

Gary Roberts expressed his concerns with the landfill odors that affects his adjacent farm and the health of nearby citizens.
