# COMMUNITY DEVELOPMENT BLOCK GRANT – NEIGHBORHOOD REVITALIZATION (CDBG-NR)

- Grantor: NC Department of Commerce Rural Economic Development Division
- Maximum Award: \$400,000
- Grant Activity: Buncombe County Home Repair Program
  - Supports home repair for low-and moderate-income homeowners
  - Available to homeowners outside the City of Asheville
- Subrecipient Managing Program: Asheville Area Habitat for Humanity



## CDBG-NR GRANT ADMINISTRATION COUNTY ACTIVITIES TO DATE

- Submitted CDBG-NR Award Documents
- Issued RFPs (April & July 2023)
- Selected Subrecipient (Asheville Area Habitat for Humanity)
- Submitted Annual Report and Extension Request (Approved by NCDOC)
- Executed Subrecipient Contract (\$200,000/40+ Repairs)
- Convened Selection Committee
- Selected First Five (5) Home Repair Sites




### HOME REPAIR SELECTION CRITERIA

- First qualified in first come, first served order unless:
  - Triaged for emergency repairs
  - Referred to another appropriate organization
- Income Qualified
- Unit Qualified
  - Deeded real property
  - Outside the City of Asheville
- Repair Eligible

#### **Eligible Repairs**

- □ Plumbing repairs
- ☐ Structural repairs where hazards exist
- ☐ Electrical repairs where hazards exist
- ☐ Bath repairs where hazards exist
- □ Roof repair/replacement
- ☐ Heating systems repair/replacement
- □ Wheelchair ramps
- ☐ Hand railings and grab bars
- ☐ Kitchen and bathroom adaptations
- □ Doorway widening

Note: Asheville Area Habitat for Humanity maintains the waitlist and provides the waitlist from which potential recipients are identified.



# CDBG-NR GRANT ADMINISTRATION ACTIVITIES GOING FORWARD

- Amend Subrecipient Contract to Expand Scope (\$300,000/60+ Repairs)
- Additional Home Repair Sites Selected in Groups (5-10/Group until 60+ Selected)
- County Conducts Environmental Reviews (Submitted in Groups)
- NCDOC HRC & REDD Reviews Environmental Reviews (Reviewed in Groups)
- Asheville Area Habitat for Humanity Begins Home Repairs (Once NCDOC Cleared)
- County Monitors Subrecipient (Based on Contract & CDBG-NR Guidelines)
- Subrecipient Prepares/Submits and County Processes Draw Requests
- County Prepares/Submits Reimbursement Request to NCDOC REDD
- 2026 County and Subrecipient Project Closeout with NCDOC REDD
