NATIONAL ALLIANCE TO END HOMELESSNESS (NAEH) RECOMMENDATION REGARDING SHELTER

Increase crisis response capacity to meet 30% of the immediate problem solving/shelter needs of unsheltered homelessness.

Implement <u>newly funded effective shelter* bed capacity by 30%</u>. Identify <u>non-congregate</u> <u>site(s)</u> which would significantly improve the number of people accepting shelter placement. Refer to shelter inventory to see the list of current shelter beds. This <u>should</u> <u>happen in conjunction with retooling existing shelter options</u> to be effective.

* Effective shelters embrace a Housing First approach, implements safe and appropriate diversion, offers immediate and low-barrier access to anyone facing a housing crisis, measure shelter performance to improve results, practice cultural humility and inclusion, and follow HUD's Equal Access Rule.

CoC REQUEST FOR PROPOSAL (RFP) DETAILS

Low Barrier Shelter Capacity

- 100 Non-Congregate Shelter Beds; 50 Additional Congregate Beds in Flexible Space
- Alignment with Shelter Planning Team Recommendations
- Serves populations unable to access existing shelters

Period of Performance

- Contracts begin: September 2024
- Operations begin as early as: January 2025
- Provision of services for minimum of one year

Operations

- Reduce typical barriers to entry
- Extensive staffing, more intensive management
- Supportive services on site
- Align with Housing First best practices

IDENTIFIED NEED: SALVATION ARMY

During the Proposal Analysis process the Shelter Workgroup identified a need to maintain current shelter bed capacity.

The Salvation Army is unable to expand beds immediately but requests support with operational funding for one year to continue existing shelter bed provision through December 31, 2025.

The Salvation Army is pursuing bed expansion with organizational leaders and undergoing strategic planning to include currently owned properties in Asheville.
