## A RESOLUTION APPROVING EXECUTING TWELVE (12) STRUCTURE LEASES WITH MILESTONE DEVELOPMENT, INC.

- WHEREAS, pursuant to N.C. Gen. Stat. §160A-272(c)(2) the County may lease a radio tower for communication purposes for a term up to twenty-five (25) years;
- WHEREAS, on October 3, 2023, the Board of Commissioners authorized the County to enter into Marketing Master Agreement with Milestone Development, Inc.; and
- WHEREAS, pursuant to the Marketing Master Agreement, Buncombe County agreed to enter into structure leases with Milestone for Milestone to market the available radio tower spaces to third parties to improve cellular and internet service in rural areas; and
- WHEREAS, pursuant to N.C. Gen. Stat. §160A-272(b) on September 23, 2024, the County published a public notice describing the property to be leased, the annual lease payments, and announcing the council's intent to enter into these twelve (12) structural leases with Milestone Development Inc.;
- WHEREAS, the structure leases are for the following radio towers,
