- The French Broad River Metropolitan Planning Organization (FBRMPO) is an intergovernmental partnership for transportation decisions in the Census Designated Urban Asheville area
- Local transportation investments prioritized through the FBRMPO
- Currently governed by a 2013 Memorandum of Understanding
