# EARLY CARE & EDUCATION



All care is regulated by NC Division of Child Development and Early Education (NC DCDEE):

- Licensed programs (more than 4 hours)
- Part-day, unlicensed regulated programs (4 hours or less)

#### As of September 2024...

Types of licensed programs:

- Child Care Centers 100 (92 serving 0-5)
- Family Child Care Homes (FCCH) 7
- Afterschool only licensed programs (ages 5-12) – 15
- Total licensed programs (ages 0-12) 107

Publicly-funded programs that make care more affordable for parents:

- Head Start (3- to 5-year-olds)
- Early Head Start (0- to 2-year-olds)
- NC Pre Kindergarten (4-year-olds)

# Covid Impact




The closure of child care facilities, the high cost of providing care, and a workforce shortage continue to impact child enrollment. Stabilization grants to support teacher salaries put in place during the pandemic by DCDEE are also coming to an end.


# Buncombe ENROLLMENT over time in licensed facilities (ages 0-5)

#### Total Children Served (0-5)






#### Buncombe County Children in Care (0-5) by age

### Helene's impacts on local ECE

- Most programs closed for a month+
- 8 locations with significant physical damage; 3 still closed
- Reopening with makeshift handwashing stations and water bottles
- Little guidance from DCDEE
- Loss of staff and students



### Helene Data from Recovery Grant Application

- BPFC grant application open Dec 20 - Jan 10
  - 52 unique responses, covering
    82 licensed centers and homes
  - 90% response rate
- All data reported by directors
- Purpose: to understand lost revenue and expenses incurred due to hurricane

## Lost Revenue

- Total reported lost revenue Sept 27-Jan 10: \$1,544,522.14
  - 9 programs reported being closed past Nov 1
  - 7 programs reported NO lost revenue
  - Range: \$0-\$117,000
  - Average loss per enrolled child: \$416
- Recovery funds disbursed (DHT funds): \$1,310,193 (84.4% of total)
  - PLUS \$530 retention bonus direct to every staff

Expenses (incurred or anticipated) • Total reported expenses: \$769,900

 Demolition/construction, furniture, equipment, playground repairs & equipment, classroom materials, food, etc.

• Recovery funds disbursed to 8 centers (CFWNC funds): \$244,000

 Plus \$1,000 to all 9 home-based programs (BPFC private funds)

Anticipate using state funds (\$2.3? million) for this too.

- # staff lost homes: 25
- # staff temporarily displaced: 57
- # staff in homes, but extensive damage: 103
- # staff unsure about: 147

#### A new private sites applied and approved to provide NC Pre-K

#### 46 families received transportation supports

Most opted for gas cards, as few child care centers are on a bus line. Seven car seats requested.



# **18** children received summer care and education before starting kindergarten

10 in new YMCA pre-k summer site 8 in regular NC Pre-K site



#### Teachers increased their education by at least 12 credit hours

Eight participants completed more than 20 credit hours

#### 13 credit hours (avg) per participant completed since fall 2022

Minimum: 3 Maximum: 38
