Growth & Development

1. Encourage a diversity of housing as a foundation for affordable, healthy and thriving communities, particularly for the most vulnerable residents

<u>Example goals</u>: Development of attached dwelling units, preservation of naturally occurring affordable housing, funding affordable rental units, increasing BIPOC owner-occupied rate

2. Maximize the use of land, guiding development to targeted growth areas that lead to resilient communities

<u>Example goals</u>: Incentivizing development in targeted growth areas, conservation in development plans, greenway expansions, redevelopment of county properties



Economic Development

1. Increase opportunities and support for the local workforce

Example goals: Promoting worker benefits through economic development, connecting people with employment resources

2. Increase access to quality internet

Example goals: Broadband expansion, bridging digital divide

3. Increase economic and business opportunities Example goals: increasing wages, BIPOC small business support





Education

1. Enhance early & adult learning

<u>Example goals</u>: expansion of child care & pre-k, decreasing "disconnected youth", increasing library participation

2. Improve equity in education

<u>Example goals</u>: work toward parity for BIPOC youth in kindergarten readiness, school to court referrals, and graduation rates





Community Health

1. Increase coordination and resilience of community health services to create a healthier and safer community

Example goals: increasing participation in NCCARE360, decreasing EMS responses, independent living support

- 2. Increase equitable outcomes in physical, mental and behavioral health and increase social connectedness
 <u>Example goals</u>: infant mortality disparities, suicide prevention, wellness
- 3. Improve community well-being by providing person-centered, trauma informed services

Example goals: reduce disparities in foster care, overdose prevention



Public Safety

1. Increase prevention and harm reduction

Example goals: gun violence prevention, reducing disparities in the jail, risk reduction, increasing pretrial effectiveness

2. Enhance public safety

Example goals: emergency response timeliness, public safety trainings, child protection

3. Advance collaboration/coordination of individualized diversion services

Example goals: alternate emergency responders, diversion programs, domestic & sexual violence prevention



Energy and Environment

1. Preserve agricultural heritage and prioritize the conservation of natural resources

Example goals: support for farmers, recycling, streambank restoration, land conservation

- 2. Reduce greenhouse gas emissions and protect air quality Example goals: emission reduction, solarize campaigns, composting, renewable energy
- 3. Increase hazard mitigation and disaster preparedness to support a climate resilient community

Example goals: FEMA community rankings, risk assessment, hazard awareness

Committee-Driven Changes for FY26

- Use/create data to target organizations that are underrepresented in specific focus areas.
- Improve method for geographic diversity via population served versus main location.
- ✓ Limit organizations to only apply for one SPG project per year.
- ✓ Do not fund capital projects.

- Use a funding methodology that prioritizes overall scores and balance between priority areas.
 - Lock in a funding scenario methodology before awards are determined.

Demographic Data

Cease the Harm audit consisted of internal & external services of City and County

- One of the key findings was insufficient data-driven practices to collect racial demographic data across programs, services, pathways, and resources
- Lack of demographic data prevents a targeted understanding of service delivery and program effectiveness
- After a review of current data collection practices, Buncombe County is undertaking a project to collect demographic data for community investment grants:
 - Pre-award survey during application phase will help us better understand the organizations that are applying for and receiving county funds
 - Post-award data collection and reporting will help us better understand the impact of the funds on populations in our community
 - Categories to include: BIPOC; LGBTQ; People with Disabilities; Veterans; Women; and Zip Code
 - Including but not limited to Strategic Partnership Grants
 - Plan to implement pre-award survey in FY2024 and post-award reporting in FY2025

County Management Input

✓ Consider prioritizing one or more focus areas over others each year

Limit on how many competitive grants an organization can apply for in a year

Commissioner support for Strategic Partnership Grant program
 Liaison(s) from SPG committee to participate in Board of Commissioner meetings as necessary
