Addendum # 1

The following questions were asked by potential bidders (listed in no particular order):

1)There are 74 items on the bid under the Curaplex name- the bid states we cannot substitute. Curaplex is a private label for BoundTree- that means that BoundTree is the only one that can bid on these items, can these items be removed from the bid or can we bid a substitute for them?

These are preferred brands, but alternates may be evaluated and considered as substitute.

2)Will you accept price adjustments during the year if we receive and increase from the manufacturer?

3) What are the terms of the renewal period for pricing? Will price adjustments be allowed?
